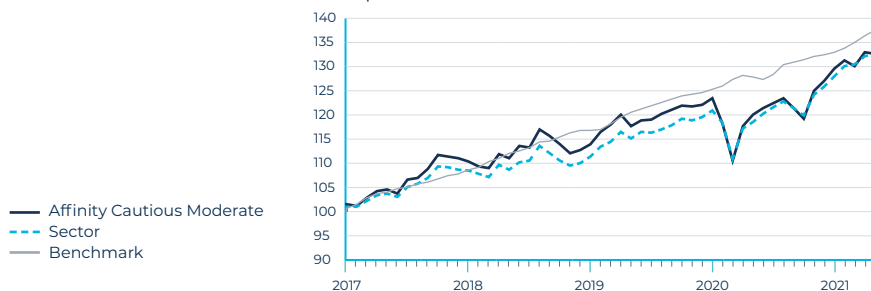

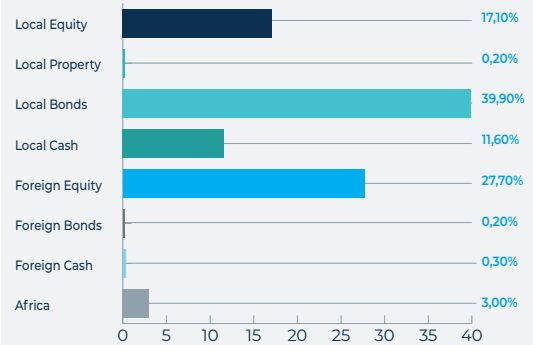

ASSET ALLOCATION

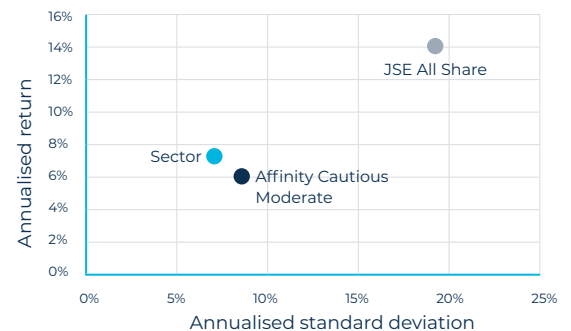


Asset allocation is one month lagged.
