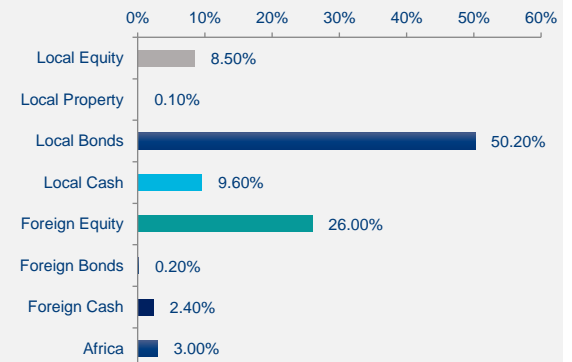

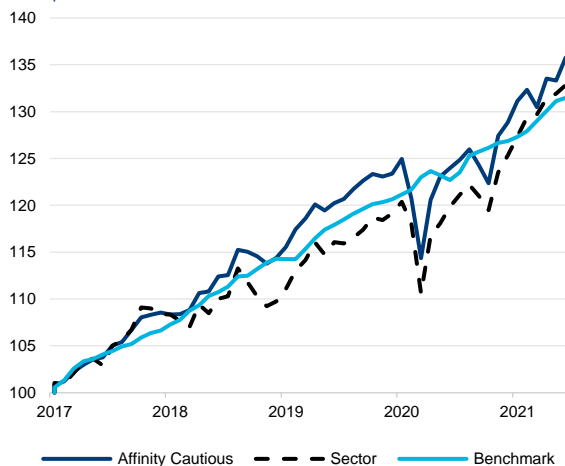
ASSET ALLOCATION
