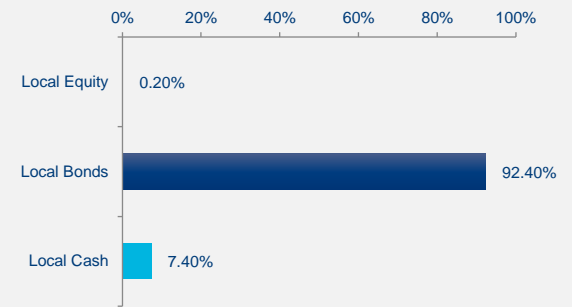

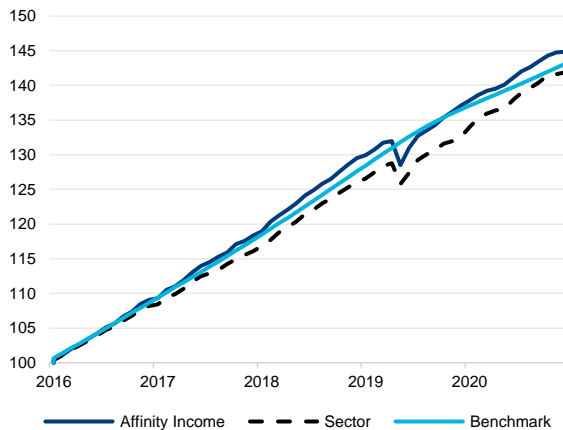
### ASSET ALLOCATION



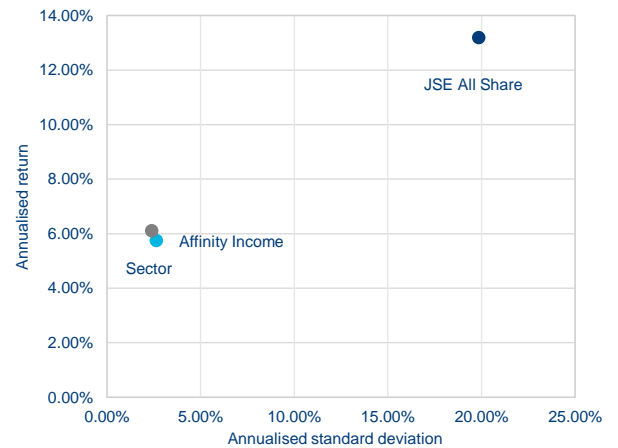
