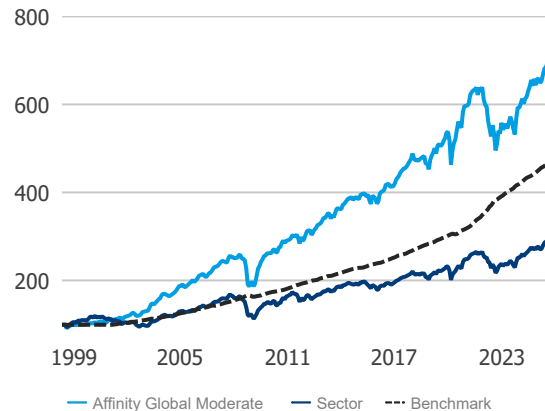

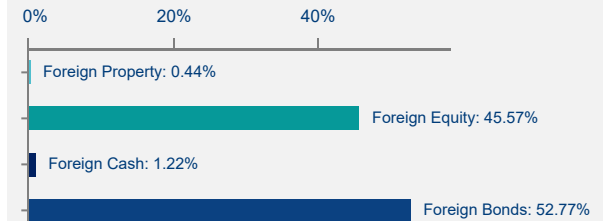

ASSET ALLOCATION



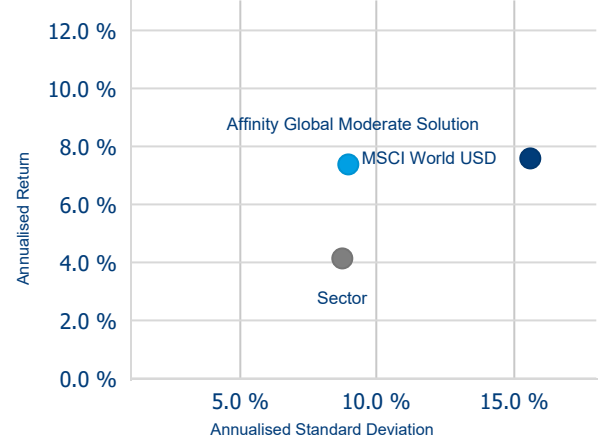
