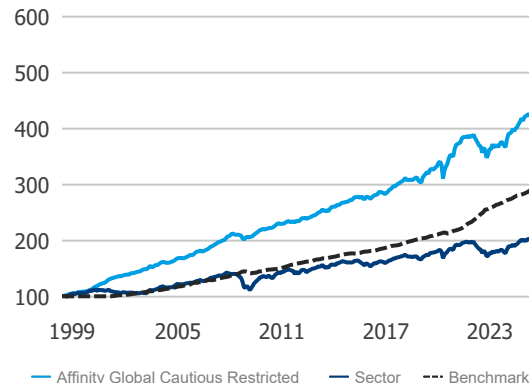

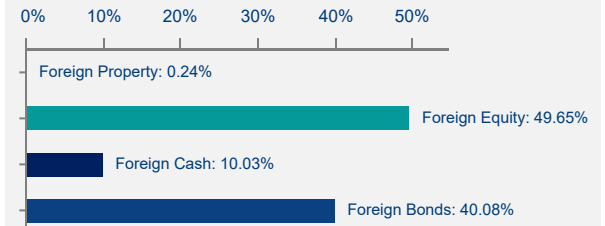

Asset allocation is one month lagged.

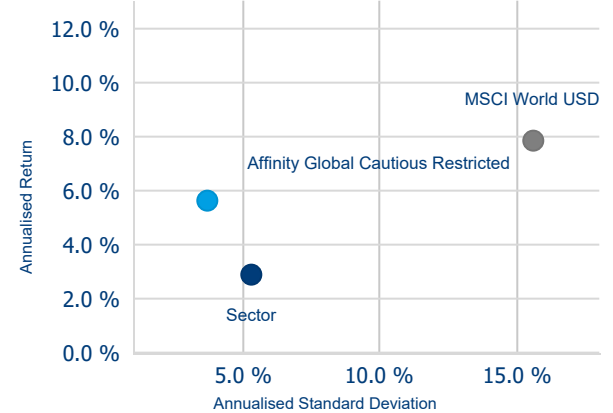
