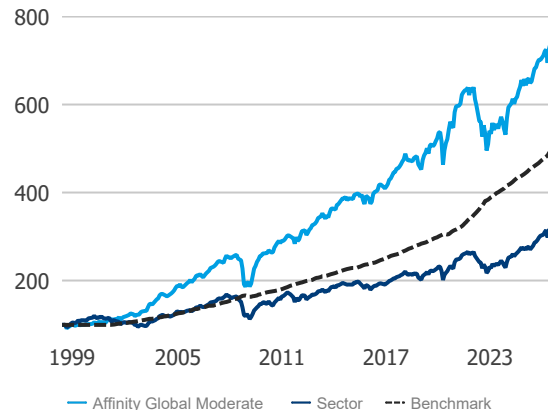

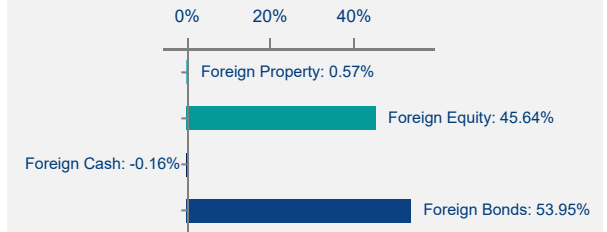

ASSET ALLOCATION



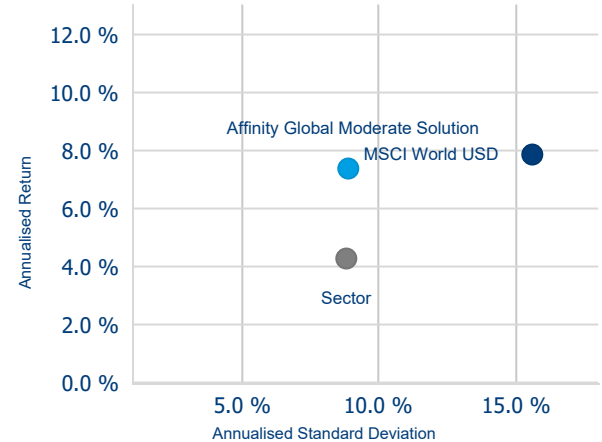
